The centre piece of Riverland is two 40ft shipping containers converted in a giant island bar, while five individual kitchens have been created from three 20ft shipping containers that will create an authentic food truck street vibe. Spots to celebrate

Riverland is a unique venue for functions; with views of the iconic Brisbane River and Story Bridge, accommodating exclusive and nonexclusive areas up to 675 guests. Relaxed and casual high bar tables throughout the venue allows your guests to sit and stand creating a more casual style event.

Minimum beverage spends required to reserve an area.

Full venue for 675 guests.

Our function space

Exclusive use for up to 150 guests cocktail style.

Access to VIP bar service area: Guest will be provided with wrist bands and allocated a VIP area at the bar for service. 65" LED TV great for photo slide shows and presentations. PA and audio system: bring in your own DJ, Duo, connect your own device to our system or use our own in-house music. Wireless Microphone for speeches. Select food from our street kitchens or pre-order from our shared food menu and have our staff deliver to your spot.

Street kitchens

Riverland Street Kitchens offer interchanging authentic street food served from shipping containers converted into 5 kitchens. Select pre-ordered function food for guests from any kitchen and have our staff deliver to your area. Function food is available on preorder and payment when making a reservation for 20 or more guests.

The food vendors are always rotating and changing which means the date of your event will pre-determine what selection of food is available. Ask for a copy of the Shared Food Menu upon making your reservation. Each share plate is a fixed price and is only available when making a reservation for 20 or more.

Alternatively, guests can order directly from the kitchen's daily menu. The Street Kitchens are open daily from 11am to 9pm.

Drinks

Serving from 80ft of bar frontage is a drinks selection worthy of exploring. 40 taps and 15 beers and ciders and a vast bottled range means even the biggest enthusiasts will find something to tickle their tastebuds.

For the wine aficionados a selection from Australia's best winemakers and appearances from some international stalwarts make up a list to please the palate. We can send you a drinks list at the time of your enquiry.

Functions and reservations require a minimum spend on beverages purchased.



The Important Stuff

Tentative bookings

A tentative booking can be placed for a maximum of 7 days. If written confirmation and deposit is not received, all bookings and reservations will be released.

Minimum spend and deposit

Minimum beverage spends and deposits apply to bookings and reservations at Riverland. The amount may vary depending on the day of the week and the time of the year. The minimum spend applies to beverage purchases only. Where a minimum spend is necessary for a reservation, a 10% deposit will be required to confirm the booking. If no deposit is provided, the space will be deemed tentative and may result in the loss of booking. Your deposit will be deducted from your final bill at the conclusion of your function.

Confirmation of details

All details are required to be confirmed 7-10 days prior to your function, unless otherwise discussed with Riverland.

Cancellations

All function cancellations must be made in writing to our Venue Manager. Where more than 60 days' notice is provided from function date, the deposit amount will be refunded in full. Cancellations made less than 60 days' notice provided from functions date will result in forfeit of the deposit.

Payment

Full payment must be made at the immediate conclusion of your function.

Decorations

We love decorations so please discuss your options with us before your night. All decorations will need prior approval and cannot cause damage to the venue and must be removed at the conclusion

of your event. Consideration must be given to other patrons. The client and/or organisers are financially responsible for damage caused to Riverland property.

Duration

Riverland is licensed on;
Sunday-Wednesday: 11am to 12am;
Thursday: 11am to 1am,
Friday-Saturday: 11am to 3am,
however all functions and events will end 30 minutes prior to closing time. Duration time will be discussed with you at the time of your query.

Minors

Please keep in mind that we are a licensed venue and minors can only be on the premises and attend private functions if they are accompanied by a responsible adult, who is either their parent or legal guardian. The venue would have to be notified prior to the event of any minors attending. The minors are not allowed to consume alcoholic beverages. The venue has the right to turn away any guest of a private function at the door if they don't provide a valid ID upon request, so please ensure everyone has their identification with them.

Responsible service of alcohol

Riverland Management is required by law to obey government restrictions on the responsible service of alcohol. It is Riverland management, staff and security responsibility to monitor the supply of alcohol and insure guests are not intoxicated. The function or event may be terminated and deposit forfeited if the following laws are being breached by any guest

- Supplying liquor to a minor
- Supplying liquor to a person who has been cut off
- Any anti-social behaviour towards other guests, patrons or staff

The Important Stuff

- Any destruction of property
- Any guest refusing to leave when requested
- All other relevant legislation

We encourage the host to work with our management, staff and security to insure all guests not only have a good time but also make it home safely. ID will be required to be scanned by all guests 18 years and over entering the venue after 10pm.

Client liability & responsibility

The person(s) or organisation listed as the Client shall be liable for all the costs and charges raised as a result of the agreed booking. The Client is required to inform all relevant persons involved in the organising of the event of the Important Stuff. It is understood that the client will be responsible to ensure the orderly manner of guests. Riverland Management reserves the right to exclude or eject any persons from the event or premises without liability.

Loss or damage to riverland property

The Client and/or organisers are financially responsible for ANY damage or breakages sustained to Riverland and/or equipment owned by, sub hired or supplied by Riverland, by the client, organisers, guests or any other person attending the function or event. Riverland will not accept any responsibility for the damage or loss of items prior to or after the function.

Riverland may end a function or event earlier for the following reasons

- Responsible Service Alcohol (RSA) not being adhered to
- Function naturally winding up
- Safety concerns
- At the manager's discretion
- Music/audio levels
